I'm writing you in hoping that you can help my sister. Her name is Lisa Courtney inmate #214106. She called me on 02/13/19 in a panic. Apparently there is another female inmate that is bullying her along with some of the inmates friends. On 2/13/19 she stated that the inmate slapped her and Lisa said she went to Lieutenant Lofton and reported the incident. Lisa said she was torn in a holding cell where Lieutenant Lofton called her white trash and spit in her face. While in the holding cell the inmate that had slapped her apparently stole some of Lisa's belongings including a iPad which she was able to get back. Another incident was during the recent commissary pass out she stated that someone associated with the inmate snatched her bag and took half of her commissary. The inmate and other inmates have started calling her a police brat and trying to get her to fight them. Since this has all happen the Lieutenant has actually moved this inmate to a bunk very close to Lisa. My sister has been locked up for 3 years and she has never asked me to call anyone because she feels unsafe or threatened. I'm very worried about her safety and feel mine and her hands are tied. I'm reaching out to you for some kind of help. I'm not sure what can be done but I wish someone would please go and talk with Lisa to get down to the bottom of this issue. She doesn't feel she can turn to any of the authorities over her pod. Thank you for your time.

Lisa said she was torn in a holding cell where Lieutenant Lofton called her white trash and spit in her face. While in the holding cell the inmate that had slapped her apparently stole some of Lisa's belongings including a iPad which she was able to get back. Another incident was during the recent commissary pass out she stated that someone associated with the inmate snitched her bag and took half of her commissary. The inmate and other inmates have started calling her a police brat and trying to get her to fight them. Since this has all happen the Lieutenant has actually moved this inmate to a bunk very close to Lisa. My sister has been locked up for 3 years and she has never asked me to call anyone because she feels unsafe or threatened. I'm very worried about her safety and feel mine and her hands are tied. I'm reaching out to you for some kind of help. I'm not sure what can be done but I wish

someone would please go and talk with Lisa to get down to the bottom of this issue. She doesn't feel she can turn to any of the authorities over her pod. Thank you for your time.

From what I'm gathering the inmates have a problem with Lisa just because she went to the officers saying I need help someone is trying to jump me. I know you are a very busy man in the position you hold but I'm a very concern family member. She has requested for transfer to Washington County but I'm hoping maybe someone can remove her from this current building.
